1. **THE NAME OF THE SOCIETY** :-  
The name of the society shall be shall be " LORD BUDDHA EDUCATIONAL FOUNDATION SOCIETY "
2. **REGISTERED OFFICE** :-  
The Registered office of the society shall be situated at Foundation School Building  
Maurya Vihar, Khagaul, Patna -801105  
The Registered office may be changed at any time by the society and it will be informed to  
I.G. Registration with 15 days of such change.
3. **Area of Operation** - All India.
4. **Aims & Objectives** :-  
The main aims and objectives of the society are as follows :-
  - a. The society will be run by the members of the managing committee and it will work for the betterment of all sections of society, in the field of science and technology, (commerce, law etc) and social welfare.
  - b. To establish, maintain and develop schools of various level any where in India for over all d3velopment of children / youth.
  - c. To society shall work for the advancement and propagation of education among scheduled tribes, scheduled castes, backward class, down trodden and other weaker section of the society.
  - d. To promote and undertake programme for physical mental and moral development of youth through yoga, creative art, debate and other available means.
  - e. To promote adult education programme in order to educate neo literate and illiterate people near and around the place.
  - f. To organize conference, seminars, symposium for students as well as for the teachers for better understanding of the subject matters concerning about the basic health, Civic sense and spiritual development of the mankind.
  - g. To educate the people for the eradication of social evils like dowry system, child marriage child labour and drug addictions.
  - h. To establish and maintain libraries, common rooms, computer room, reading room for the benefit and convenience of students and staffs.
  - i. To spread knowledge and information to all section of the society through news papers, pamphlets, handbills and publication of articles.

AMENDED RULES AND REGULATION  
OF

" LORD BUDDHA EDUCATIONAL FOUNDATION SOCIETY "

1. DEFINITION

- A- Society means :- " LORD BUDDHA EDUCATIONAL FOUNDATION SOCIETY "
- B- Committee means :- The Managing Committee of the Society.
- C- Office bearers mean :- President, Secretary & Treasurer
- D- The year means :- From 1st April to 31st March,
- E- Body means :- The General Body of the Society.
- F- Act means :- Society Registration Act 21, 1860

2. MEMBERSHIP :-

The membership of the society shall open for Indian citizen irrespective of the caste, creed and community above the age of 21 years and interested in social welfare work and who end who will abide by the rules and objectives of the society is eligible for membership. One have to submit petition for membership which will duly be approved by the executive committee. The admission fee will be Rs. 51/- and Annual fee will be Rs. 25/-

3. APPLICATION FOR ADMISSION :

- a. Every application for the admission as member of the society shall be addressed to the Secretary of the society.
- b. No application shall be considered unless the applicant is proposed by a member and seconded by another such member.
- c. Every such application shall be considered in the meeting of the Managing Committee and shall be accepted or rejected by a vote of majority same as those falling under rule 4 of these rules.
- d. Every applicant shall be informed in writing by the Secretary about the decision of the Managing Committee which shall be final.

4. TERMINATION OF MEMBERSHIP :

- a. By failing the payment of his annual membership fee without reasonable ground.
- b. By resignation.
- c. By failing to attend three meeting without information continuously.
- d. By death.
- e. By unsound mind.
- f. By order of the Secretary if any member will not abide with the rules of the society or if found quilt of misconduct.

5. **FORMATION OF MANAGING COMMITTEE**

- a. Subject to the provision of these rule the affairs of the Institution shall be administered and controlled by a Managing Committee and shall comprise of Nine (9) members including office bearers elected by General Body for a period of 3 years.
- b. The members of the managing committee shall continue as such for a period of 3 years. Vacancy created by death or otherwise, shall be filled in with in 3 months of the occurrence of such vacancies by the sole authority of the President.

6. **POWER & FUNCTION OF THE MANAGING COMMITTEE :-**

- a. To carry out the aims and objects of the society.
- b. To administer and control the affairs and funds of the society and exercise all powers of the society
- c. To do all other lawful acts, matters, things and deeds as may be conducive to the expedient interest of the society.
- d. To purchase, take on lease of in exchange or hire or otherwise acquire any movable or immovable property for the purpose contract obligations and arrangements on suitable terms

7. **GENERAL BODY MEETING. :-**

- a. The General Body meeting of the society will be attendee by 11 members. The First General Body meeting of the Society shall be held with in six months of the expiry the financial years. in which the first General Body meeting was held thereafter, the Annual general Body meeting of the society shall be held with eighteen months from the date of its registration under societies Registration Act 21 of 1860
- b. The management committee may whenever it deems necessary call and extraordinary general body meetings.

8. **PROCEEDING OF THE ANNUAL GENERAL BODY MEETING. :-**

- a. Passing the Accounts of the previous financial year.
- b. Election of office bearers and the members of the managing Committee to fill the vacancies caused by the retirement or otherwise.
- c. Appointment of Auditor for the next year.
- d. To receive and adopt the annual report, the statement of accounts for the proceedings year, and the financial budget estimate for the ensuing year.
- e. To consider any other matter deemed important by the President or the majority of the members present

At General body meeting 1/3rd person shall form a quorum if the quorum is not present with a half an hour of the fixed time the meeting shall be adjourned for the same date and time and at the same place for the next week and if the quorum is not present at the adjourned meeting to the members present shall be deemed to form quorum.

The Notice of the Annual general body meeting shall contain the items of business to be transacted at the meeting and shall mention the place and time of the meeting. The notice of the Annual general body meeting shall be given at least 10 (Ten) days before the meeting.

9. GENERAL BODY :

The annual general body meeting, shall be held at least once in a year at such time and place as fixed by the Secretary.

10. POWER AND FUNCTION OF THE OFFICER BEARER :-



PRESIDENT: -

The President shall preside at all meeting of the Managing Committee and of the society when he is present and shall exercise such other powers as are conferred up him by these rule. The President may call for an emergent meeting at shorter notice. The president, that a resolution has been carried or lost shall be conclusive unless such a declaration is challenged and a poll is demanded on poll, being demanded the same shall be taken in such a manner as the President may be discretion determine. In case of a time, the president shall have a second or casting votes.

SECRETARY :

- a. He shall be incharge of the office and shall be responsible to the general body in all matters. He shall contract in all way and means of the position of the association and shall have right to improve it.
- b. He shall be convener of all the meetings
- c. It shall be his duties to see that the resolution at the respective meeting are implemented and give to effect to timely.
- d. He shall have liberty to expend for the purpose of the society without sanction of the managing committee to do all such other lawful notes deeds of things as incidental or conducive to the attachment of society
- e. Secretary shall have power to pass wills regarding any payment.
- f. He shall produce the accounts of the society before the Managing Committee.
- g. He will produce the expenditure of the society before Managing Committee for approval.
- h. He shall appoint, suspend, discharge, fix the salary, make payment of the employees of the Institutions in consultation with the President and conducted by the society on behalf of the Managing Committee.

**TREASURER :**

- a. The Treasurer will act under the direction of the committee.
- b. Any amount exceeding Rs. 1000/- which is not required for immediate use shall be paid into such bank or banks as may be approved by the committee.
- c. the Treasurer shall ordinarily receive all payments and disburse the amount passed by the Secretary and shall maintain proper books of accounts.

**11. BANK OPERATION :**

The account of the society shall be kept properly and the Bank Account will open in a Bank or Post office by the name of the Society and it will be operated by joint signature of either two office bearer such as President, Secretary or Treasurer.

**12. Source of Income. :-**

- a. By donation from its member, other individuals, private firms, companies and organization.
- b. By Government aids.
- c. Any other legal sources.

**13. INSPECTION OF THE REGISTER :**

All records will be kept in registered office any member wish to inspect can do so with the prior permission of the President or Secretary.

**14. AUDIT OF ACCOUNTS :**

- a. The accounts of society shall be audited at least once a year by an auditor appointed by the general body and it will be placed before the General body meetings.
- b. Inspector general of Registration, Bihar on his discretion any time may get audited accounts of society by recognize chartered accountants and for this fee of the chartered Accountants will be born by the Society.

**15. INTERPRETATION:**

The authority for interpretation of any of these bye laws rules or regulations made there under which are in force or that may come into force shall vest in the Managing Committee and their decision in the matter shall be final.


**16. AMENDMENT OF RULES :**

The rules will not be amended or altered unless two third members of the society have agreed to the proposed amendment or alterations in a General body meeting provided at least one months notice has been given to the members about the proposed amendment.

**17. LEGAL PROCEEDING :**

All the legal proceeding by or against the society shall be represented by the Secretary of the Society. All documents exacted by or infavour of the society shall be in the name of the Secretary of the Society.
